Outdoor Water Restrictions Reduced

Hours change to reflect those of state restrictions

Effective Saturday, October 7, Forsyth County's outdoor water use restrictions will be reduced to allow for extended hours of watering. The new outdoor water use restrictions are as follows:

Even-numbered addresses (addresses ending with the number 0, 2, 4, 6, 8 or no number) may water on Wednesdays and Saturdays, **with no watering allowed between 10:00 a.m. and 4:00 p.m.**

Odd-numbered addresses (addresses ending with the number 1, 3, 5, 7 or 9) may water on Tuesdays and Sundays, with no watering allowed between 10:00 a.m. and 4:00 p.m.

No outdoor watering is permitted on Mondays, Thursdays and Fridays.

The new hours reflect those of the state's current level one restrictions.

VERY SERIOUS ALERT!!

Around 11pm this past Monday, October 9th two young males were seen taking mail from a mailbox. The Sheriff's office was given a description and later found the youths. The next day in the morning light a search took place and mail was found thrown over a fence on Loblolly Lane and on the Gran Forest side of Haw Creek Rd across from the Church. The crime scene specialists were called and evidence was bagged. We will keep you posted on the outcome.
